4.	To usher for the evening performance on Sunday, August 22, 2010 even though you may want to go home earlier. (Please understand that this is important.)
5.	To report promptly each day and follow directions.
6.	To never drive or ride on the back of anyone's golf cart throughout the entire lowa State Fair. The program distributor (to drive) is the only exception.
7.	To cooperate by working at entrance gates distributing daily programs.
8.	Work in the Agriculture Building doing assigned Iowa State Fair activities.
9.	Work at the gates handing out promotional materials if requested to do so by the lowa State Fair.
10	. Keep a good attitude toward carrying out responsibilities even when it is too hot, too cold or raining.
11	. Conduct myself at all times with credit to me, my family, my school and the FFA.
12	To refrain from smoking, chewing tobacco, drinking alcohol, using drugs or sexually inappropriate behavior.

18	To agree that lack of cooperation regarding any rules or Iowa State Fair responsibilities will be cause for returning home immediately upon the request of FFA Staff or Iowa State Fair officials.
19	. To bring own bedding (sheets, blankets, pillow), towels and toiletries.


